RE: 2016-2017 Occupational License #2488 Revocation Hearing

Dear Ms. Williams:

The City of Grain Valley requires that any organization doing business in the City obtain and hold current a City Occupational License (*Grain Valley Municipal Code Chapter 605*). Issuance of said license is subject, in part, to section 144.083 of the Missouri revised statutes – Sales and Use Tax.

On September 27, 2016 you reported that your Missouri retail sales license was revoked for non-payment of sales tax due. At your request, I contacted Mr. Wright at the Department of Revenue and verified that your license has been revoked. Per RSMo 144.083.2, *"The revocation of a retailer's license by the director shall render the occupational license or the state license null and void"*.

Per Section 605.190 of the City Code, *"The Board of Aldermen shall have the power to suspend or revoke any license granted under the terms and provisions of this Chapter whenever it shall be shown, or whenever they have knowledge that a licensee is conducting said business or manufacturing in violation of any ordinance of the City. The Board of Aldermen shall have the power to issue subpoenas and all necessary processes and to require the production of papers, to administer oaths and to take testimony and to make findings thereon."*

A hearing on this matter will be held by the Board of Aldermen the evening of Wednesday, October 5, 2016 at 6:30 p.m. to discuss this revocation. Please refer to City of Grain Valley Municipal Code Chapter 605, Section 605.190 to review your rights as a licensee in these proceedings.
