## **ITEM XII: Public Hearing**

- Mayor Todd opened the public hearing for **Property Tax Levy** at 7:03PM –
- A Public Hearing for Tax Levy for 2022 there was an increase in the City's assessed valuation – 4 parts to the levy
  - General Service .4685 current levy; .3907 proposed
  - Debt Service .8362 current levy; .5427 proposed
  - o Parks and Recreation .1035; .0863 proposed
  - Public Health.0412; .0344 proposed
- 1.4494 current total levy and proposing total levy at 1.0541
- This would be a considerable decrease going forward with the numbers we have at this time –at the time of the ordinance we will have a better idea of what will be proposed.
- Alderman Skinner asked if on September 11<sup>th</sup> if the numbers will remove those that have requested appeals; Mr. Murphy stated it should reflect information up to that point They have 54,000 appeals and have gone through 22,000 of them so far. Those numbers of the ones in the appeal process have been frozen. These numbers are coming in later than usual as these numbers need to be turned in to the county by the end of September.

- Alderman Knox asked if there was an idea of how many appeals were being rolled back as a result of the appeal; No, the city does not have that information
- Alderman Arnold asked if the reduction is required by the Hancock law; yes
- Mr. Craig stated the county assesses in odd years and this year they are seeing and are seeing a 26.8% increase in the assessed valuation compared to last year – state law requires levies to be rolled back to keep revenue neutral; can increase up to 5% based on CPI- the City's did roll back approximately .40 cents as a result
- Alderman Bray stated he has a general feeling that decreased increases are still more than 15%- he's not confident the numbers are going to hold. He's concerned if we go back too far what our options are to keep us in a better position
- Mr. Murphy stated every avenue is being reviewed at this point and we are checking the boxes and doing what we are supposed to do at this time
- Mayor Todd stated after talking with 41 action news recently, they mentioned they
  reached out to the auditor, and if a lawsuit occurs and rolled back to 2022 levels- then
  the board can take action for up to 3 years if that were to happen; Mr. Murphy stated it
  would require another public hearing
- Alderman Bray asked if the county responded to our letter we sent; One reached out to meet with Mayor and cancelled at last moment.
